CITY ORDINANCE: Section 131.08 UNLAWFUL ASSEMBLY

It shall be unlawful for the host or person in charge of any property to allow a party, gathering or assembly, that exhibits any of the following: loud music; loud or boisterous voices causing complaints by neighbors; alcohol possession or consumption by persons under 21; illicit drug use or possession; blocking streets or driveways by vehicles or people; obscene or profane language or gestures. The person sponsoring, hosting, renting or organizing such assembly may be charged with a violation of this section and be subjected to a fine of up to \$1087.00 and/or 30 days in jail.

CITY ORDINANCE: Section 131.07 UNREASONABLE NOISE PROHIBITED

The playing of amplified music or other sounds or music or other sounds without amplification, transmission of amplified music or other sounds through open window or door openings, transmission of amplified music through exterior speakers, personal conduct of an excessively loud nature; in such a manner as to unreasonable disturb the peace, quiet, comfort or repose of any person in his home or dwelling, or in any public area; provided, however, that upon application to and approval by the DIRECTOR OF PUBLIC SAFETY, written permits may be granted to responsible organizations to broadcast programs of music, speeches, general entertainment or announcements as part of and incident to community celebration of national, state, or municipal occasions, or public festivals, provided that traffic on the streets is not obstructed by reason thereof.

Any event to be held on the Public Beach or any public property, which is expected to have an attendance of 75 people or more (WITH THE EXCLUSION OF WEDDING CEREMONIES ONLY), shall require the approval of City Council and an Activity Permit. Appointments with City Council shall be submitted through the Municipal Clerk of Council, Mary Cunningham at 843-513-1836.
